Group Leaders will support their Coach Leader's decisions and will actively support all the rules of the Pilgrimage.

RESPONSIBILITIES

- To work effectively in small groups.
- To know the members of the group before leaving on the Pilgrimage.
- To help plan and deliver types of worship e.g. Masses
Station of the Cross
Night Prayer
- Will participate in coach meetings.
- Will be sensitive to issues around race, gender and sexuality.
- Will know the rooms of each member of their group.
- Will maintain a professional relationship with all young people throughout the week in Lourdes.
- Will assist the Coach Leader in ensuring the safety and well being of young people throughout the week in Lourdes.
- Will carry out the duties and task entrusted to them by the Coach Leader.
- Will assist the Coach Leader in ensuring the full participation of all the young people in the Youth Pilgrim Programme.
- Will make every effort to identify and respond to young people who show signs of being marginalised, reporting any concerns to the Coach Leader.
- Will support staff to ensure singing in bars is halted a 11.30 pm and in making sure that young people return safely a 12 midnight.
- Will take positive action when they see young people acting in a manner that will demean the work of the rest of the young people and inform the appropriate Coach Leader.
- Will make themselves familiar with the Child Protection Procedures of the Archdiocesan Youth Pilgrimage.
